Slide One - General Rules of the Halls

You have signed an Accommodation Licence Agreement indicating that you have read and understood the Terms & Conditions of the Licence and you agree to abide by them.

Slide Two – Accommodation Deposit & Inventory

Your Accommodation, Deposit & Inventory form

Your accommodation deposit includes £250.00 for potential damages to your room, kitchen and communal areas during the year and/or loss of keys.

On your arrival you will be given an arrivals inventory form. You are required to complete it and return it to the Accommodation Team within your first week.

Your Accommodation, Departure Inventory & Deposit Refund

At the end of the year, the Accommodation Support Staff will conduct a departure inventory on your room and communal areas. Any damages/charges you have accrued will then be deducted from your £250.00 deposit before the remaining balance is refunded to you.

Slide Eight – Health and Wellbeing Information

What must I do in the Halls to contribute to Health and Wellbeing?

1. Wash up, clean up and leave the kitchen clean and tidy as my flatmates would leave it for me.
2. Remove rubbish from my bedroom and dispose of it in the outside bin store.
3. Keep my bedroom clean and tidy.
4. Put food waste in the bin and dispose of out-of-date food that is in the fridge.
5. Put into practice what I will learn in the Food Hygiene Course. The Accommodation Support Team will notify you when you need to complete this course.

Slide Nine – COSHH

COSHH The Control of Substances Hazardous to Health

Hazardous substances can be found at home and in most workplaces and are covered under COSHH UK regulations regarding handling and use of hazardous substances in the workplace.

This includes in accommodation so it is important for you to know of and understand the potential health hazards of certain substances.

Slide Ten – COSHH Part 2

COSHH The Control of Substances Hazardous to Health

The health risks from hazardous substances are many and varied, for example, infections caused by bacteria and viruses, allergies, poisoning or toxic effects. Eyes can become damaged from foreign bodies such as dust, flying particles or chemicals.

Hazardous substances can cause both immediate and long-term health problems. For example, a cleaner splashing bleach on their skin could cause a burn or inflammation of the skin or use of aerosols could cause an asthma attack. However, a splash in the eye could cause permanent eyesight damage.

Slide Eleven – COSHH Part 3

Hazardous substances often contain warning labels to indicate the risk of using the substance. Select the symbols below to find out more.

Irritant - Skin and eyes

Respiratory – Asthma and longer term issues

Flammable - Can catch fire easily

Toxic – Poisonous on skin, eyes or if ingested

Corrosive – Can burn skin

Gas Under Pressure – May explode if heated

Slide Twelve – COSHH Part 4

COSHH The Control of Substances Hazardous to Health

So long as cleaning substances are used sensibly and appropriate precautions are taken such as wearing gloves; generally, they should cause little or no adverse effects to the user.

Slide Thirteen – Food Hygiene

- Food hygiene checks are conducted every weekend - fridges are checked for out-of-date food which will be disposed of.
- No metal containers are to be used to store food in fridges.
- Leftover food must be covered and labelled with the date you put it in the fridge.
- Any leftovers must be eaten within 3 days.
- Defrost food in the fridge and label it with the date you took the food out of the freezer.

Food Hygiene Key Facts

Bacteria starts to grow and multiply on food after 10 - 20 minutes.

To keep it fresh, store correctly in the fridge and consume within the Use By date.

If you are worried, here are some tips to ensure you are a good flat mate.

1. If you have cooked your dinner, it is expected that you wash your dirty pots and clean up after yourself after you have eaten. For a clean & healthy living environment you would expect this of your flatmates also.
2. Negotiate with your flatmates, how you will label your fridge food, which drawer you have in the freezer and which cupboard you will store your food. This prevents possible future disagreements where you might find you've used someone's milk or eaten their cereal.
3. Do not take other residents' food, pots, or gadgets without first asking first.

Slide Nineteen – Pets

What about pets? I hear you ask.

You are not permitted to have pets or animals in the Halls of Residence; the only exception being support animals.

Any support animals will need to be approved by the Accommodation Service Manager, along with information from a medical professional working with you.

Slide Twenty – Car parking and on site driving

You have signed an Accommodation Licence Agreement indicating that you have read and understood the Terms & Conditions of the Licence and you agree to abide by them. This included Parking Regulations.

Residents must be aware of the parking regulations and are advised that failure to observe the conditions could result in a financial penalty of £85.00 from the car parking monitoring service Horizon Parking Ltd.

Why might you face disciplinary procedures?

Obviously being such a well behaved student, it will be highly unlikely that you will face disciplinary procedures.

If you bully or harass fellow students.

If you tamper with Fire Safety Equipment. Including covering smoke detectors, misuse of fire doors and deliberate release of the emergency release buttons on entry/exit doors and gates.
